1. Welcome and objectives for the meeting

The Chair, Marie Burnham (MB) welcomed the committee to day 2 of the 13th weight management guideline update meeting and thanked those who had travelled to London to attend in person.

Jon Littler (JL), Project Manager, then took the committee through a brief induction session on the use of the hybrid system at the London Office so they could familiarise themselves with the usage of the microphones and make sure they're able to be heard both in the room and on Zoom.

The Chair then asked if there were any new declarations of interest. No new interests had arisen since the meeting on Monday.

The Chair then moved on to the first main item on the agenda.

2 – 3. Review question 2.3 – Weight management programmes for children and young people

For the next two agenda items, the Chair introduced Michellie Young (MYO), Technical Analyst. Having reviewed the clinical evidence for this review question at previous meetings, MYO presented the committee with the existing recommendations for discussion.

The Chair thanked the committee for their guidance, and MYO for her work in preparing this presentation, and moved to the next item on the agenda.

4. Guideline amalgamation review and discussion

For the next item, the Chair introduced the medical editors for this guideline. Susie Burlace (SB) and Bethan Dorsett (BD).

SB and BD presented their progress on amalgamation (the version of the updated recommendations brought together into one coherent guideline). The committee then gave their feedback, asking questions on why certain choices had been made and making suggested changes.

MB then thanked BD and SB for their work in preparing this presentation, and the work they'd done on amalgamating the recommendations so far, before moving on to the final main item on the agenda.

5. Review question 2.4 – Healthy living programmes for children and young people

The Chair introduced Shreya Shukla (SS), Senior Technical Analyst, who provided a brief update on the development of review question 2.4, which the team have been working on alongside the Universities of Bristol and Durham who have been developing this for Cochrane.

MB thanked SS for her update before moving on the any other business.

6. Next steps and any other business

JL advised the committee that the bariatric surgery referral recommendations, and responses to stakeholder comments, would be refined based on the committees' feedback over the two days of committee 13, subsequently publishing on **Wednesday 26 July 2023**. Further feedback would be required from the committee would be requested in the meantime.

Additionally, he advised them that the next two-day committee would take place on **Monday 12** and **Tuesday 13 June 2023**.

MB then thanked the committee for their input over the two days, and those who travelled to London to attend day 2 in person, before closing the meeting.
