2. Mark Bellis, Alcohol Expert Witness Presentation

Mark Bellis gave a presentation on the contribution of alcohol to sexual activity and teenage pregnancy. The presentation covered:

- Alcohol harm and relationship with conception
- Drunkenness and unprotected sex
- Link with stress, insecurity and self-worth
- Drinking behaviour and violence / regretted sex
- Under-age drinking behaviour and culture
- Need for a better inter-professional understanding of alcohol and sexual activity
