1. Welcome and Apologies

1.1. Observers of the day's meeting included: Sarah Dunsdon and Clifford Middleton who will be replacing Sarah as Guidelines Commissioning Managers for the IND Guideline.

3. Minutes of GDG 7

The Minutes of GDG 7 were reviewed and agreed by the GDG. There were no matters arising from the minutes of GDG 7.

4. The Chair presented an overview of the agenda.

5. Economic Model: Botulinum Toxin vs Augmentation Cystoplasty

5.1. RH presented the economic model to the group. The model compared the cost effectiveness of two methods for the treatment and prevention of incontinence in neurological disease: augmentation cystoplasty and the injection of Botulinum toxin (BTX) in the bladder wall.

6. Review of Clinical and Health Economic Evidence:

6.1. What is the safety and efficacy of the catheter valve compared with urinary drainage bags in neurological disease?

6.1.1. Introduction: Catheter Valves

SH provided an introduction to catheter valves. This introduction covered the type of catheters and valves used and the storage systems available for urinary waste. The pros and cons of using this equipment were discussed, along with the impact on patients' quality of life and suitability for catheter valve use.

6.1.2. Clinical Evidence:

No randomised controlled trials (RCTs) or observational studies were identified comparing catheter valves with urinary drainage bags for improving outcomes in patients with neurological disease or injury.

6.2. What is the safety and efficacy of urethral tape and sling surgery compared with a) bladder neck closure b) usual care in neurological disease?

6.2.1. <u>Introduction: Urethral tape and sling surgery</u>

SH delivered a presentation that introduced the group to the surgical procedures involved in urethral tape and sling surgery, and AW delivered an introductory presentation on considerations for the paediatric population fo this surgical procedure.

6.2.2. Clinical Evidence: 23 observational studies were included in the review. Three observational studies focussed on tape surgery and 20 looked at sling surgery. No studies were identified comparing urethral tape or sling surgery with bladder neck closure. The evidence was presented according to whether the population was adults, children, or a mixed population. It was further subgrouped into whether or not bladder augmentation was performed before or at the same time as the tape and sling surgery.
