1. Welcome and objectives for the meeting

The Chair, Marie Burnham (MB) welcomed the committee members and NICE attendees to the ninth weight management guideline committee.

MB then informed the committee that apologies had been received which are noted above.

MB then asked if the committee had any new interests to declare before the meeting began. No further interests were declared.

Finally, MB and committee members reviewed the minutes from committee meeting 8 and agreed them as an accurate record of the meeting.

2. Review question 1.3 – What approaches are effective and cost-effective in identifying overweight and obesity in children and young people/adults, particularly those in black, Asian and minority ethnic groups?

MB introduced Michellie Young (MYO) who presented a recap of the evidence supporting our draft recommendations for review question 1.3 so these recommendations could be finalised.

The committee provided their feedback on MYO's presentation, and the required refinements were made. MB thanks MYO for her work in preparing the evidence and the recommendations and moved to the next section of the meeting.

3. Review question 2.1 – What is the effectiveness and cost effectiveness of total or partial diet replacements, intermittent fasting, plant-based and low carbohydrate, in achieving and maintaining weight loss in adults living with overweight or obesity?

MB introduced Shreya Shukla (SS) and Alex Allen (AA) who gave a presentation of the clinical evidence to support the diet question contained in review question 2.1.

After their brief presentation, AA and SS asked the committee for any questions or feedback they had. MB then thanked AA and SS for their work, the committee for their comments and input, and closed this section of the meeting.

4. Review question 2.1 – Health economic evidence presentation and health economic model structure

MB introduced Miaoqing Yang (MY), Jeremy Dietz (JD) and Alfredo Mariani (AM) to the committee.

They took the assembled members through the health economic evidence for review question 2.1 as well as the model they had used to reach their findings. The committee were asked for their opinions of the results and to offer any feedback they could.

MB thanked MY, JD and AM for their work and move on to the final section of the day.

5. Review question 1.4 – What approaches are effective and cost-effective in increasing uptake of/ barriers and facilitators to increasing uptake of weight management services in adults, particularly those in black, Asian and minority ethnic groups

Before wrapping up the day's contents in preparation for day 2 of the meeting, MB introduced SS and MYO to take the committee through the last presentation of the day.

SS and MYO gave the committee an overview of the current recommendations around increasing the uptake/barriers/facilitators of weight management services for adults. They took suggestions from the committee on how these recommendations should be worded and made some draft edits. The final recommendations will be discussed and formalised at a later date.
