- 2. Apologies were received from Len Bowers and Faisil Sethi.
- 3. No new declarations of interest were raised.
- 4. Minutes from GDG 3 on 23 July 2013 were reviewed and approved.
- 5. Craig Whittington led the GDG through a Guideline Management System (GMS) refresher session.
- 6. CW led the GDG through his presentation on evidence for brief or fast acting pharmacological interventions.
- 7. Eric Slade delivered his presentation on the health economics: brief or fast acting pharmacological interventions.
- 8. Peter Pratt gave a presentation on rapid tranquilisation, summarised from the CG25 2005 Violence Guideline.
- 9. CW gave a presentation on the evidence for Pro Re Nata pharmacological interventions.
- 10. Tim Kendall led the GDG through the Department of Health Letter from Norman Lamb regarding the Positive and Safe campaign: a two year programme to end the use of outdated and damaging restraint and restrictions in health and care services.
- 11. The writing plan and writing tasks was reviewed.
- 12. Sabrina Naqvi explained the three month timeline extension that has been granted by NICE, mainly to cover the expansion of the scope to include children and young people.
