1. Welcome and objectives for the meeting

- Pharmacological treatments for managing periods of physiological stress in people with adrenal insufficiency
- Pharmacological treatments for managing periods of psychological stress in people with adrenal insufficiency

		health (including how to ensure an adequate supply of medicines, advice on what to do in certain situations such as when exercising, travelling, working non-standard hours or taking part in religious observances such as fasting)?
	•	What information and support do people diagnosed with adrenal insufficiency need for the prevention and emergency care of an adrenal crisis?
	•	What is the clinical and cost effectiveness of pharmacological treatments for managing periods of physiological stress in people with adrenal insufficiency including:
		a) planned and emergency invasive procedures
		b) pregnancy and intrapartum care
		c) intercurrent illness and periods of physiological stress including minor (for example, colds) and major illnesses (for example, severe infection, cardiac events)?
	•	What is the clinical and cost effectiveness of pharmacological treatments for managing periods of psychological stress in people with adrenal insufficiency?
