Assuming this happens, off- pump is not for every patient. Also, if the more difficult cases are done on pump arent they likely to do better. Its all very well having the patients co-mordidities the same in these studies but there is no way of measuring the position of the targets on the heart and the standard of the target vessels	Thank you for your comment. NICE recognizes that patient selection is important and section 1.3 of the guidance recommends that 'Patient selection and treatment should be carried out by cardiac surgical teams who are skilled in both off-pump and on-pump surgery.'
