Briefing

Age: The incidence of open-angle glaucoma increases with age, most commonly presenting after the age of 65 (and rarely before the age of 40).

Ethnicity: Primary open-angle glaucoma is three to four times more common in Afro-Caribbean people in whom it tends to present earlier and is more severe.

Disability: People with open angle glaucoma are likely to be covered by the Equality Act 2010 if their condition has had a substantial adverse impact on normal day to day activities for over 12 months or is likely to do so. Primary open-angle glaucoma is responsible for 10-12% of all cases of registrations for severe visual impairment in the UK.

This was not thought to have an impact on the assessment of the procedure. No exclusions were applied.
