### 1. Welcome and objectives for the meeting

#### 2. Presentation of clinical evidence

AF introduced NICE Technical Analyst Yolanda Martinez (YM) who presented the clinical evidence of invasive breast cancer for the review question: What is the optimum tumour-free radial margin after breast-conserving surgery for adults with ductal carcinoma in situ (DCIS) and/or invasive breast cancer to minimise the risk of local recurrence and maximise overall survival and patient satisfaction?

The committee were then invited to discuss and interpret the evidence presented.

AF thanked YM for her presentation and the committee for their input.

# 3. Presentation of clinical evidence

AF introduced NICE Technical Analyst Fernando Zanghelini (FZ) who presented the clinical evidence of ductal carcinoma in situ and neoadjuvant therapy for the review question: What is the optimum tumour-free radial margin after breast-conserving surgery for adults with ductal carcinoma in situ (DCIS) and/or invasive breast cancer to minimise the risk of local recurrence and maximise overall survival and patient satisfaction?

The committee were then invited to discuss and interpret the evidence presented.

AF thanked (FZ) for his presentation and the committee for their input.

#### 4. Health economics presentation

Following a lunch break, AF introduced NICE Technical Analyst (Health Economics) Hannah Tebbs (HT) who presented the health economic evidence for the review question: What is the optimum tumour-free radial margin after breast-conserving surgery for adults with ductal carcinoma in situ (DCIS) and/or invasive breast cancer to minimise the risk of local recurrence and maximise overall survival and patient satisfaction? HT then invited comments and questions from the committee.
