The committee asked questions about the clinical evidence.
- C. The committee discussed the recommendations and write-up for review question 1.1: In people with suspected hypertension, which test is most accurate in identifying whether hypertension is present, as indicated by the reference standard, ambulatory blood pressure measurement?
- D. Rafina Yarde presented the clinical evidence for the review question 'In adults with treated primary hypertension, what is the best method of measuring blood pressure (home, ambulatory or clinic measurement) to assess the response to treatment and predict cardiovascular events?' The committee

asked questions about the clinical evidence.

E. Rebecca Boffa, Senior Research Fellow at the NGC, led a discussion on finalising the malignant or accelerated hypertension review protocol. The committee discussed and finalised the protocols.
