1. Welcome and objectives for the meeting

3. Review question 1: What are the barriers and facilitators to (i) self-identification by carers as carers, and (ii) identification of carers by health- and social-care professionals?

The Chair introduced AM, NGA Systematic Reviewer, who presented an overview of

the qualitative evidence for review question 1 to the committee.

The committee were given the opportunity to ask questions.

AM introduced NS, NGA Systematic Reviewer, who presented an overview of recommendations from existing published NICE guidelines that were relevant to review question 1 to assist committee discussions.

The Chair introduced committee member DJ, who presented feedback on the evidence review for question 1 on behalf of the topic group.

The Chair led a discussion of the evidence with the committee, and the committee drafted recommendations based on review question 1.

4. Update on economic work

The Chair introduced PJ, NGA Economist, who presented an update on the economic work to the committee.

The Chair thanked PJ for his presentation.

5. Review of draft recommendations and committee discussion of evidence for RQ6, practical support

JFr, NGA Senior Systematic Reviewer, presented the latest draft version of the recommendations and committee discussion of evidence for RQ6 to the committee for review.

The committee reviewed the relevant sections and suggested some edits.

The Chair thanked JFr for her presentation.
