The impact on equality has been assessed during guidance development according to the principles of the NICE equality policy.

4.1 Have any additional potential equality issues been raised during the consultation, and, if so, how has the Committee addressed them?

A number of equality issues were raised by stakeholders during consultation. These were in relation to:

socioeconomic factors and disadvantaged groups

A stakeholder highlighted that capacity and access to dental and oral health services will need to be an ongoing matter of review for commissioners and service providers to ensure that this awareness does not increase health inequalities within this population. The committee agreed and further highlighted the needs of the disadvantaged population in the guideline rationale.

It was also suggested that there might be value in highlighting that free NHS Dental treatment is available for all children and teenagers under 19 years in full time education. The committee agreed and this was added to the guideline rationale and included in the evidence review.

A stakeholder also noted that lack of access to dental and oral health services disproportionally affect the most vulnerable and socially disadvantaged individuals and groups in society and it is vital that services are tailored to support them effectively. Furthermore, another stakeholder added that the guideline should recommend including extra measures for health professionals to proactively engage

with children and young people from hardly reached or disadvantaged communities to make sure they are supported to attend regular dental appointments. The committee agreed it was not the remit of NICE to decide whether free NHS treatment could be extended to more population groups but further highlighted the needs of the disadvantaged population and lack of dental and oral health services in the guideline rationale.
