## 1. Welcome and objectives for the meeting

The Chair welcomed the Committee members the 10<sup>th</sup> guideline committee meeting on Self Harm: assessment, management and preventing recurrence.

Morning presentations

The Chair introduced Rachel Connolly and Claire Maynard, both NGA Systematic Reviewers who gave a presentation on review question 2.2 What is the most effective approach to obtain consent, ensure confidentiality and promote safeguarding when people have self-harmed? Rachel Connolly and Claire Maynard took questions from the group. The Chair thanked Rachel and Claire for their presentation.

### Afternoon presentations

The Chair introduced Rachel Connolly and Claire Maynard, both NGA Systematic Reviewers who gave a presentation on review question 2.1 to the committee members present in the meeting. The group was not quorate for this agenda item and the Reviewers will present this again at a future meeting.

It was also noted that the Topic Advisor, Nav Kapur's paper was included in this review question 2.1, What are the most effective ways of supporting people to be safe after self-harm? The Topic Advisor Nav Kapur was present at the meeting to answer questions from the committee about the paper, however Nav Kapur withdrew from the committee discussions about the recommendations. The Chair thanked Rachel and Claire for their presentation.

The Chair introduced Ferruccio Pelone, NGA Economist who gave a presentation on the Health Economic model for 5.2, What psychological and psychosocial interventions (including safety plans and electronic health-based interventions) are effective for people who have self-harmed?

The Chair and Katherine Andrea, Guideline Lead spoke to the group to Review and edit the recommendations for reviews: 3.1, 4.1, 5.1 and 6.1.
