### REPORTS OF DISCUSSIONS AT THE MEETING

### 1. Introductions

MR welcomed everyone to the 5<sup>th</sup> meeting of the CUADT GDG.

Apologies for absence were received from Dr John Graham (NCC-C Centre Director), Dr Andrew Champion (NCC-C Centre Manager), Dr Shreerang Bhide and Dr Tom Roques (TR).

MR welcomed Selvam Thavaraj – a consultant head and neck pathologist at Guys & St Thomas hospital (and academic position at Kings College London) replacing Julia Woolgar on the guideline development group.

### 2. Declarations of Interest

The following declarations of interest were declared prior to the meeting:

ST declared that he is co-applicant for the FiGaRO study (phase I pilot study
of FDGPET in Guiding Intensity Modulated Radiotherapy to Oropharyngeal
tumours). Funded by the King's Health Partners Research and Development
Challenge Fund. Involved in designing the HPV testing protocol. This interest

was categorised as non-personal pecuniary, specific but as it is not funded by the healthcare industry ST can participate in discussion on all guideline topics.

- ST declared he is local investigator for the BOHEMIAN trial (Biomarkers of Hypoxia Evaluation with Molecular and 64Copper (II) diacetylbis (N4)methylthiosemicarbazone (CuATSM) Positron Emission Tomography/Computed Tomography (PET/CT) Imaging Techniques in Head and Neck Squamous Cell Carcinomas). Funded by King's Health Partners Research. This interest was categorised as non-personal pecuniary, specific but as it is not funded by the healthcare industry ST can participate in discussion on all guideline topics.
- ST declared that he is local investigator for the PREDICTR trial (Improving treatment selection using predictive and prognostic classifiers of treatment response for head and neck cancers and dysplasia). Funded by CRUK. This interest was categorised as non-personal pecuniary, non-specific (and not funded by the healthcare industry) meaning that ST can participate in discussion on all guideline topics.
