- 2. The chair highlighted the aims of the day, which were for the group to meet each other, to understand the process for producing guidelines, the importance of health economics and to advise on the review questions.
- 3. SP, Director of the National Collaborating Centre for Mental Health, informed the group of the importance of declaring all interests each member may have. At each meeting GDG members will be asked to declare if they have any new interests to ensure the process is clear and transparent. - 4. SP gave a presentation introducing the work of the NCCMH and how it can support the development of this guideline. The NCCMH will work with the NCGC to ensure the reviews and recommendations do not stand in conflict with each other.

- 6. Erin Whittingham from Patient and Public Involvement, NICE, gave a presentation regarding the involvement of service users and carers in the guideline development. She highlighted the importance of service user and carer members of the group to develop a relevant and well rounded guideline.
- 7. SP gave a presentation on the scope, highlighting what will and will not be covered in the guideline.
- 8. OMV, the systematic reviewer on this guideline, gave a presentation introducing the group to systematic reviews and meta-analysis.
- 9. OMV gave an overview of the draft review questions prepared by the NCCMH team
- 10. SS, Senior Information Scientist for the NCCMH, gave a presentation on searching for studies and the sources that will be searched
- 11. ES, the Health Economist for NCCMH, gave a brief introduction to Health Economics.
