2.	Dissemination & Implementation	JMy presented a brief recap from the last session. The GC identified further things to consider around implementation and also what the GC can do to better engage with implementation issues. This information will also be updated in the dissemination and implementation issues log. Early engagement with the sector was identified as an urgent action. 3.	Review of the evidence: Q3. Recognition indicators	<ul> <li>HR gave an overview of the evidence for review question 3: What emotional, behavioural and social (non-clinical) indicators relating to children and young people should alert practitioners to the possibility of abuse and neglect?</li> <li>HR also informed the GC that there were significant overlaps with the NICE guideline CG89: When to suspect child maltreatment and that there might be evidence that might be relevant to this guideline. HR presented the relevant sections and recommendations of CG89 for the GC to consider. This will then be revisited in more detail at the next GC meeting.</li> </ul>	
4.	Question 3 - Writing recommendations (group work)	The GC formed two groups with a mixture of practitioner and service user/carer members in each. Each group was facilitated and scribed by the NCCSC. Each group wrote recommendations based on the evidence statements and with their own collective knowledge and expertise.
