REPORT OF DISCUSSIONS AT THE MEETING

1 Welcome and apologies

JG welcomed everyone to the 10th meeting of the prostate cancer GDG.

Apologies for absence were received from Andrew Champion, Kath Nuttall and Elise Hasler.

2 Declarations of interest

3 Discussion

NB presented the results of the Delphi consensus survey on active surveillance for topic 6. The GDG drafted recommendations and drafted the LETR paragraph.

MP presented a clarification of the evidence in the HTA for topic 2. The GDG discussed their draft recommendations and their LETR paragraph in light of this.

MP presented the full economic report for topic 1, including the results of the threshold analysis.

KC and MP presented the new evidence following the update searches. The GDG reviewed their draft recommendations and LETR paragraphs for topics 7 and 9b (clinical evidence) and topic 10 (health economics).

The GDG discussed the editorial changes to 2008 recommendations for Chapter 2 and 5.

The GDG discussed the editorial changes to the 2008 and new recommendations and reviewed the LETR paragraphs for Chapters 3, 4, 6, 7 and 8.

The GDG reviewed the final needs assessment.

JMcB presented an overview of the NICE pathways and Information for the public that will be developed and published alongside the guideline.

The GDG voted on and agreed the 10 key priorities for implementation and the 5 key research recommendations.
