#### MINUTES OF THE MEETING

### Monday 6<sup>th</sup> December 2010

### 1.1 Agenda item 1: Introductions, objectives, declarations of interest, minutes of the last meeting and review of GDG 2:

GM welcomed the group back to the third meeting of this group. GM discussed the objectives for the meeting. No additional declarations of interest were received and the minutes for the previous meeting were agreed. Apologies for were received from Gurch Randhawa.

### 1.2 Agenda item 2: Call for evidence - update:

MB updated the GDG on the process used for the call for evidence. We had requested information on the identification of potential donors, required referral and clinical triggers. Much of the data is already published in the PDA. Representatives of the NHSBT PDA team had agreed to run the analyses which they hoped to complete in March. We would then be able to provide feedback to the GDG in the final meeting.

# 1.3 Agenda items 3 & 4: Evidence presented/Discussion of evidence & agree evidence statements (Clinical Triggers & Required Referral)

MB gave a presentation on what structures and processes <u>including timing for</u> <u>referral and criteria for consideration</u> are appropriate and effective for identifying

potential DBD and DCD donors. The GDG discussed this with specific consideration to clinical triggers and required referral. Following this discussion the GDG agreed the evidence statements for this question.

### 1.4 Agenda item 5: Draft recommendations (Clinical Triggers & Required Referral)

The group revised the recommendations on the structures and processes for identification of potential donors taking into account the evidence presented for clinical triggers and required referral.

### 1.5 Agenda item 6 & 7: Evidence presented/Discussion of evidence & agree evidence statements and draft recommendations (Care Pathway)

MB gave a presentation on how the care pathway of deceased organ donation should be coordinated to improve potential donors giving consent. The GDG discussed all the evidence available for this question. Following this discussion the GDG agreed the evidence statements for this question. The group drafted recommendations relating to the care pathway.

MB gave a presentation on what key skills and competencies are important for healthcare professionals to deliver the recommendations in this guideline.
