- 1. Philip Conaghan welcomed the group to the tenth meeting of this GDG. PC introduced the observers to the meeting and asked the GDG for any new DOIs since GDG meeting 1.
- 2. Margaret Constanti presented the preliminary results for the OA modelling. The GDG agreed with the methods (sensitivity analyses conducted) and findings.
- The GDG agreed revisions to be made to the recommendations in light of the preliminary results for the OA modelling and any additional revisions to assist clarity. Further sensitivity analyses were discussed and the results will be presented at the next GDG meeting.
- 4. Emmert Roberts presented the evidence reviewed for the consideration of timing for referral to surgery review, which consisted mainly of qualitative studies. The GDG agreed any new recommendations on the basis of the presented evidence.
- 5. Lyn Knott, the NICE Senior Editor delivered a presentation on the editorial process for NICE guidelines.
- 6. The GDG discussed some of the revisions to the algorithms contained in CG59. Some members of the GDG agreed to conduct the revisions after the GDG meeting.
- 7. It was agreed that research recommendations would be covered at the next GDG meeting in June.
- 8. Philip Conaghan asked the GDG whether there were any items under AOB and closed the meeting at 17:00hrs.
