Minutes

- 1. Introductions and apologies.** PS welcomed everyone to the meeting and introduced Anna Poppa, senior editor at NICE and lead editor on the CKD update.
- 2. Presentation from NICE Editor.** Anna Poppa gave a presentation explaining the 4 different NICE products – 1) full guideline produced by the NCGC, 2) the NICE guideline, 3) the NICE pathway,

which is an electronic pathway focusing on the recommendations linking to other guidance, and finally 4) the information for the public - a summary of the recommendations for patients, family members and carers and the wider public.

A summary was given about how recommendations should be phrased. They are written in the active voice, present tense. They should be as simple and as easy to understand as possible, using plain English and focusing on the action and what the reader needs to know.

- 3. Declarations of Interest.** All GDG members were asked to verbally declare any new declarations of interests since GDG 2. New declarations of interests were declared by Karen Jenkins, Fiona Loud, Robert Lewis, Ed Lamb, Paul Stevens and Sheila O’Riordan:

- 4. Draft working notes and NICE minutes from GDG2.** The draft working notes were agreed with a small amendment to the description of a study in one of the evidence reports. The NICE minutes were agreed as an accurate report of the meeting and accepted without changes.
- 5. Evidence review: Oral bicarbonate for acidosis.** The evidence report was presented by SC and the GDG discussed draft recommendations.
- 6. Evidence review: Vitamin D for renal bone disease.** The evidence report was presented by SC and the GDG discussed draft recommendations.
- 7. Draft health economics work plan.** LL presented the draft economics plan that has to be submitted to NICE by 16th January 2013. The GDG discussed the presentation and content of the economic analysis of the prioritised 2 review areas.
- 8. Completed evidence reports for hyperuricaemia and low protein diet.** JP gave the GDG an overview of the evidence reports that have been written up as a result of the last meetings.
- 9. Any other business.** Tuesday 29th April 2014 was agreed for GDG12.
