1. Welcome and objectives for the meeting

The Chair welcomed the committee members and attendees to the 1st meeting on Eczema in under 12s. The committee members and attendees introduced themselves. The Chair noted apologies received, as noted above.

The Chair outlined the objectives for the day.

2. Confirmation of matter under discussion, and declarations of interest in relation to the matter under discussion: Atopic Dermatitis (eczema) in under 12s: diagnosis and management.

The Chair confirmed that, for the purpose of managing conflicts of interest, the matter under discussion was topic Dermatitis (eczema) in under 12s: diagnosis and management.

The Chair asked everyone to verbally declare any new interests that are not listed in the registry. There were no new declarations.

The Chair noted that committee member Matthew Ridd is a co-investigator of one of the included studies in the evidence base. The NICE team had considered this declaration and considered that any risk of potential conflict is outweighed by the expertise that would be lost by excluding Matthew and therefore the decision was for the member to not participate in the initial drafting of recommendations, except to answer any questions, but otherwise to allow full participation.

The Chair advised that no interests previously declared did not prevent the attendees from fully participating in the meeting.

3. Review Question: What is the clinical and cost effectiveness of adding bath emollients (bath additives) to the management of atopic eczema in children and young people?

Caroline Mulvihill, Technical Adviser presented the committee with some introductory and methodological points.

The Chair then introduced Sarah Matthews, who presented the clinical evidence on adding bath emollients to the management of atopic eczema in children and young people.

The committee discussed the identified evidence and asked questions.
