## Notes

1. IA welcomed the group and introduced Alison Barnes, Glyn Lewis and Carolyn Chew-Graham to the group. Apologies were received from Carol Paton. The Chair asked all GDG members to declare any relevant conflicts of interest.
 

AB, MK, BM, RM, TS, JW, RB, SH, AL, PR, BS, SS all declared that they knew of no new personal specific, personal non-specific, non-personal specific or non-personal non-specific interest in the development of this guideline.

IA declared a personal non-pecuniary interest – he is a member of the MHRA Psychiatry Expert Advisory Group. IA also declared a non-personal pecuniary interest as his university research fund received an honorarium payment for IA speaking at non-promotional meeting from Wyeth

6. PR presented on Health Economics and explained in more detail how economic models would be built for this guideline.
7. RB and SP presented the definitions for terms in depression and asked the GDG for comments on these definitions. The group also discussed the various levels of severity and will bring their notes on these issues to the next meeting.

8. The group agreed on having three topic groups to reflect the three areas outlined in the Clinical Questions. The service users and carer had already discussed topic groups and allocated themselves to their preferred group. The rest of the GDG all decided to join the most relevant group for their area of expertise.
