| Matthew Callister | Specialist Committee Member | Non-financial professional and personal interests | The EarlyCDT-Lung test has been proposed as a tool for identifying people at higher risk of lung cancer who might benefit from low-dose CT screening for lung cancer. This is a distinct indication for the test than the one under review here (discrimination of malignant from benign pulmonary nodules once detected). The former indication was the subject of the Early Detection of Lung Cancer in Scotland (ECLS), first presented in abstract form at the World Conference on Lung Cancer 2019 and shortly to be published in the European Respiratory Journal. I was asked to write a blog for the British Thoracic Oncology Group regarding lung cancer screening research presented at WCLC2019 (https://www.btog.org/blog/lung-cancer- screening-at-wclc-2019/), and have recently co-authored an editorial for publication in the European Respiratory Journal alongside the main trial paper. Both the blog and subsequent editorial raise some concerns about the design of ECLS and the way in which the performance of the test has been reported by the trial group. The recommendation in both is for further research to be undertaken to determine the role of EarlyCDT in this scenario.
