This has also been noted in the accompanying committee discussion section in evidence report J.

The guideline has reiterated the importance of language and culture and how these need to be considered in the context of PTSD treatment. This is mainly related to recommendations in the previous guideline which have been refreshed to meet current editorial standards, but no evidence has been reviewed. The cross-reference to the NICE guidelines on service user experience in adult mental health (particularly with regard to sections on avoiding stigma and promoting social inclusion) and patient experience (particularly with regard to communication) is therefore included in the recommendations contained under section 1.5 of the short guideline.

The committee also developed a recommendation on additional support that may be required for people with PTSD who are admitted to hospital because of other mental or physical health problems, which addresses the needs of critically ill patients. This has also been noted in the accompanying committee discussion section in evidence report J.
