# 1. Welcome and objectives for the meeting

- The possibility of a researcher observing a GC in July to undertake research on how committees make decisions.

The committee were reminded of the anterior data presented in GC7 and were presented with apical data related to effectiveness only.

The Committee discussed the presentation and was given the opportunity to ask questions and draft comments related to effectiveness data.

The Chair introduced Eric Slade, NGA Health Economist, who led a discussion on the ESTER study for review question 5.1 What is the most effective surgical management of stress urinary incontinence, including mesh and non-mesh procedures?

#### 5. Presentation of evidence review 11.2 and 11.3

The Chair introduced Linyun Fou, NGA Systematic Reviewer, who gave a combined presentation on EVIDENCE REVIEW: 11.2 What are the most effective management options for sexual dysfunction after mesh surgery? and EVIDENCE REVIEW 11.3 What are the most effective management options for pain after mesh surgery?

The Committee discussed the presentation and was given the opportunity to ask questions, draft recommendations and rationale and impact sections following evidence review.

#### 6. NICE pathways presentation

The Chair introduced Joanna Perkin, NICE Pathways Editor, who gave a presentation on NICE pathways.

#### 7. Reviewing NICE edits to recommendations

The Chair introduced Judy McBride, NICE Senior Medical Editor, and Vanessa Nunes, NGA Guideline Lead, who led a discussion of NICE edits to drafted recommendations to date. The committee discussed these suggested edits and made some changes to the draft recommendations.
