The Chair introduced Catrin Austin, NICE Systematic Reviewer, who gave a presentation on evidence review 5.2 What is the effectiveness of surgical management of stress urinary incontinence (including mesh and non-mesh procedures), compared to pelvic floor muscle training?

The committee were presented with evidence and then drafted recommendations and the rationale and impact sections of the evidence report. The committee also reviewed related recommendations from the previous guideline CG171 and agreed necessary updates.

The committee discussed the evidence and drafted recommendations and the rationale and impact sections of the evidence report. The committee also reviewed the related recommendations from the previous guideline CG171 and agreed which recommendations required amendment.
