Katherine Jones presented the clinical evidence for the review: what is the clinical and cost effectiveness of bivalirudin as an adjunctive pharmacotherapy in adults with STEMI undergoing primary percutaneous coronary interventions?

Kate Lovibond presented the cost effectiveness evidence.

The committee discussed the evidence and draft recommendations.

5. Draft protocols

Saoussen Ftouh presented draft protocols for forthcoming reviews on early invasive management and stents. The committee discussed and amended the protocols.

6. Health economics: priority topics for original modelling

Kate Lovibond presented the results of a survey which sought the view of committee members regarding priority topics for original modelling. The committee discussed the results and agreed the top three topics for modelling in order of importance.
