1. Welcome, objectives for the meeting

What are the support needs and preferences of adults (Children & young people 4.4b) who have complex rehabilitation needs after traumatic injury when they transfer from inpatient to outpatient rehabilitation services?

The Guideline Lead introduced Alice Navein NGA Systematic Reviewer, who presented on overview of clinical evidence and presentation of evidence review for CYP.

The Guideline Lead introduced Eric Slade NGA Senior Health Economist, who presented options for economic work for Review 2.1a: What are the support needs and preferences of adults who have complex rehabilitation needs after traumatic injury when they transfer from inpatient to outpatient rehabilitation services?
