1. Welcome and objectives for the meeting

The Chair introduced herself to the committee and welcomed members and attendees to the 10th meeting of the safe prescribing and withdrawal management guideline committee. Apologies were received from Louise Trewern.

The Chair acknowledged the resignation of the previously appointed guideline Chair and outlined next steps in recruitment of a chair for the committee. The Chair then outlined the objectives of the meeting, which included a review of areas covered to date and a continuation of evidence and discussion of interventions for withdrawal of prescribed medicines associated with dependence or withdrawal symptoms.

2. Minutes of the previous meeting

The committee agreed that the minutes of GC 09 were an accurate record of the previous virtual meeting, subject to minor edits: Caroline Watson should be removed from the list of attendees and noted as sending apologies. Item 5 should be edited to indicate that further discussions will be held at a later meeting.

This included evidence reviews on monitoring, information and support, and withdrawal interventions for different drug classes (with the exception of Antidepressants, which will be presented at a later date). Evidence reviews relating to risk factors, optimal prescribing strategies and withdrawal symptoms will be looked at, during future meetings.

Withdrawal interventions (different drug classes):

- The committee developed draft consensus recommendations on important principles for approach to withdrawal of medicines
- Evidence presented to date on interventions to support withdrawal was reviewed.
- The committee discussed conclusions from the evidence presented and implications for practice.
- Potential draft recommendations were discussed.
