## 1. Welcome and objectives for the meeting

The Chair welcomed the Committee members and attendees to the 18<sup>th</sup> meeting on the Maternal and Child Nutrition Guideline.

The Chair informed the Committee that apologies had been received. These are noted above.

#### 2. Confirmation of matter under discussion, and declarations of interest

The Chair confirmed that, for the purpose of managing conflicts of interest, the matter under discussion was Maternal and Child Nutrition.

### 3. Minutes of last meeting

## 4. Morning presentations.

The Chair introduced Victoria Freeman, Systematic Reviewer, who presented Evidence review 2.3: 'What interventions are effective to increase uptake of healthy eating during pregnancy in line with government advice?'

The Chair introduced Angela Bennett, Director of Guidelines, who led the committee's discussion on the evidence for this review question and drafted recommendations based on the presented evidence and early draft recommendations from the topic group.

#### 5. Afternoon presentations.

The Chair introduced Maija Kallioinen, Guideline Lead, who led the committee on drafting recommendations for review questions 3.2: 'What do parents perceive to be facilitators and barriers for maintaining breastfeeding after 8 weeks' based on the early draft recommendations from the topic group.

The Chair introduced Maija Kallioinen, Guideline Lead, who led the committee on reviewing and signing off draft recommendations for:

- Continuing breastfeeding after returning to work or study
- Healthy weight change during pregnancy.

Maija Kallioinen, Guideline Lead, gave a guideline project update and spoke to the committee about the next steps for the Maternal and Child nutrition guideline,
