- o vitamin supplements (including Healthy Start vitamins) (quantitative RQ 1.5)

What are the barriers and facilitators to increasing the uptake of government advice for women and families with children up to five years in the following areas:

- appropriate and timely introduction to solids (complementary feeding) for babies from 6 to 12 months (quantitative RQ 4.1)
- o healthy eating and drinking in children from 12 months to 5 years (quantitative RQ 4.2)

The committee discussed the qualitative evidence presented and reviewed the current recommendations on the topic. They wrote and revised recommendations based on the evidence presented.

## 4. Afternoon presentations.

The Chair introduced Victoria Freeman, Systematic Reviewer and Maija Kallioinen, Guideline lead who presented Evidence review 4.3 – healthy eating in pregnancy:

What are the barriers and facilitators to increasing the uptake of government advice for women and families with children up to five years in the following areas:

o healthy eating and drinking in pregnant women (quantitative RQ 2.3)
