8. Agree the protocol for guideline guestion 5.2

AAA took the committee through the draft review protocol around question on the effectiveness of treatment for otorrhoea after surgery for OME. the rationale behind what interventions are effective for treating otorrhoea (ear discharge). This review will be conducted by the NGA team. The committee made changes to the draft protocol, for example, agreeing 7 key outcomes and signed the protocol off.
