3. Minutes of last meeting

The Chair asked the Committee any changes needed to be made to the minutes of the last meeting. The Committee agreed that the minutes were a true and accurate account of the meeting.

4. Presentations and discussions

The Chair introduced, Prof. Nicki Dowling, Lead Cochrane SR author (Deakin University Australia), Prof Dan Lubman, Cochrane SR author (Monash University Australia) and Alice Navein, Systematic Reviewer, who presented **RQ 4.1a evidence report** 'What is the effectiveness of pharmacological interventions for people who participate in harmful gambling (including those with comorbid conditions)?'

The committee discussed the evidence and agreed recommendations.

The Chair introduced Alice Navein, Systematic Reviewer who gave a presentation on **RQ 8.1 evidence report:** 'What works well and what could be improved in gambling treatment services, including treatments for individuals, family approaches and relapse prevention, from the perspective of practitioners, people who participate or have participated in harmful gambling, and their families, friends and others close to them?'

The committee discussed the evidence and agreed recommendations.

The Chair introduced Ifigeneia Mavranezouli, Senior Health Economist, who presented an introduction to the planned network meta-analysis for **Review 4.1b** 'What is the effectiveness of psychological and psychosocial interventions for people who participate in harmful gambling (including those with comorbid conditions)'

The committee discussed the grouping of interventions and the use of different outcome measures.

The Chair asked the lay members present if they had anything they wished to raise at the meeting and there were no new items for discussion.
