## 9. Protocol for review question 1.2:

Nathan Bromham, Senior Systematic Reviewer, presented the draft protocol for review question 1.2 What the effectiveness of treatments such as local oestrogen, ospemifene, prasterone and transvaginal laser therapy for managing genitourinary symptoms associated with the menopause?

Nathan Bromham took questions from the group and the committee discussed and agreed on the protocol characteristics.



#### 10. Protocol for review question 2.7:

Agnesa Mehmeti, Systematic Reviewer, presented the draft protocol for review question 2.7 What are the effects of hormone replacement therapy taken by women, non-binary and trans-masculine people with early menopause (aged 40 to 44) on all-cause mortality and developing:

- o venous thromboembolism
- o cardiovascular disease
- o type 2 diabetes
- o breast cancer
- o endometrial cancer
- o ovarian cancer
- o osteoporosis
- o dementia
- o loss of muscle mass and strength?

Agnesa Mehmeti took questions from the group and the committee discussed and agreed on the protocol characteristics.
