- 8 This guideline will also be used to update the NICE quality standard for fertility
- 9 problems.

## 1 Purpose of the guideline

- 11 The purpose of this guideline is to make recommendations on the
- management of health-related fertility problems, which would include both
- diseases of the reproductive system and any other physical or mental health
- problems that reduce or limit the ability to have children. As part of this, it may
- include criteria for what constitutes sufficient evidence of health-related fertility
- problems to access further services, such as referral for IVF. There are known
- complexities around access and funding in this area in particular where
- some people may have had to self-fund initial treatments to demonstrate a
- 19 health-related fertility problem in order to access further care. As part of the
- 20 Women's Health Strategy for England, the DHSC has committed to removing
- 21 non-clinical access criteria for fertility treatment, and the requirement for self-
- 22 funding for initial treatments, particularly in relation to female same-sex
- 23 couples.
- 24 This guideline will not make recommendations on funding arrangements for
- 25 the initial tests or procedures to demonstrate a health-related fertility problem.

## 1 Why the update is needed

- 2 New evidence that could affect recommendations was identified through the
- 3 surveillance and scoping process. Topic experts and stakeholders advised
- 4 NICE on whether areas should be updated or new areas added.

## 5 Why the guideline is needed

#### 6 Key facts and figures

- 7 In this guideline, the term 'health-related fertility problems' covers failure to
- 8 achieve a pregnancy:

10

- after 12 months of regular unprotected sexual intercourse or
  - after 6 cycles of artificial insemination.
- 11 It is estimated that 1 in 6 heterosexual couples in the UK need specialist help
- to conceive after trying for more than 2 years (<u>Hull et al. 1985</u>, <u>Templeton et</u>
- al. 1990). The main causes of female fertility problems are ovulatory disorders
- 14 (21%), tubal damage (14%) and endometriosis (6%). Male factors account for
- 15 26% of fertility problems. They are either due to issues with sperm production
- or sperm delivery. It is common to find both female and male factor fertility
- problems. In about 25% of cases, investigations do not reveal a defined cause
- of fertility problems; this is called unexplained fertility problems.

#### 19 Current practice

- 20 In England, decisions about providing and accessing fertility services within
- the NHS are made locally by Clinical Commissioning Groups. The existing
- 22 NICE guidance has not been uniformly implemented. There is considerable
- variation between different geographical areas, both in relation to who gets
- 24 access to fertility services and how much is offered (for example the number
- of treatment cycles). Almost 59,000 people received IVF cycles in the UK in
- 26 2019 (HFEA 2021a) but most of these were not NHS funded. The Human
- 27 Fertilisation and Embryology Authority (HFEA) has also documented
- disparities in the outcomes of fertility treatments between different ethnic
- 29 groups, although reasons for these are uncertain (HFEA 2021b).

- 1 Preserving fertility is also an increasingly common part of fertility services'
- work. Requests can come from people starting cancer treatment and those
- 3 with specific health conditions or about to undergo interventions which have a
- 4 significant risk of reducing fertility.
- 5 This guideline update aims to provide an evidence-based resource for
- 6 healthcare professionals, recognising the range of clinical situations where
- 7 investigations and treatment are needed for health-related fertility problems
- 8 and the variety of settings where these may take place, including HFEA-
- 9 licensed private clinics providing NHS funded care.

# 2 Who the guideline is for

11 This guideline is for:

10

- providers of NHS commissioned fertility services, including HFEA-licensed
- 13 private clinics
- commissioners of NHS fertility services
- people using fertility services, their families and carers and the public.

## 14 3.4 Economic aspects

- We will take economic aspects into account when making recommendations.
- We will develop an economic plan that states for each review question (or key
- area in the scope) whether economic considerations are relevant, and if so
- whether this is an area that should be prioritised for economic modelling and
- analysis. We will review the economic evidence and carry out economic
- analyses, using an NHS and personal social services (PSS) perspective, as
- 21 appropriate.
- 22 In the case of fertility treatment, NICE's preferred quality adjusted life years
- 23 (QALY) approach may not be suitable. For example, a baby who might be
- 24 conceived as a result of assisted reproduction will experience no loss in
- 25 health-related quality of life if conception does not occur. In the previous
- guideline, the psychological impact of fertility problems on parents wishing to
- conceive was used to inform a QALY framework for economic analysis.
