The Chair introduced Nicky Welton and Bea Downing, NICE Technical Support Unit, University of Bristol who presented the threshold analysis for RQ 3.2.1 / 3.3.1 What is the clinical and cost effectiveness of ovarian stimulation, intrauterine insemination (IUI) with or without ovarian stimulation, IVF with or without intracytoplasmic sperm injection (ICSI) and expectant management for people with unexplained health-related fertility problems, mild endometriosis, and people with a single abnormal semen parameter?
