## 1. Welcome and objectives for the meeting

The Chair welcomed the committee members and attendees to the 17<sup>th</sup> meeting of the fertility guideline update.

The Chair informed the committee that apologies had been received as noted above.

The Chair outlined the objectives of the meeting which included reviewing the draft guideline and research recommendations.

The Chair introduced Paul Jacklin, Health Economics Adviser, who gave a presentation on the economic model for the topic of NHS access to IVF, based on RQ 3.1.1. The committee rediscussed the recommendations drafted, based on the model results and limitations.

The Chair asked the lay members present if they had anything they wished to discuss.

The Chair introduced Maija Kallioinen, Topic Lead, who led the committee in reviewing recommendations related to RQ 4.1.1 What is the effectiveness and safety of fertility preservation for children and adults undergoing treatment for cancer and other conditions or situations which are likely to impair their fertility?

The Chair introduced Odette Megnin-Viggars, Senior Systematic Reviewer, who led the committee in reviewing the research recommendation on testicular tissue preservation.

The Chair reintroduced Maija Kallioinen, Topic Lead, who led the committee in reviewing remaining queries across the draft guideline.
