4. Intrapartum care update – Waterbirth update: Comments received at stakeholder consultation

The Chair introduced Maija Kallioinen, Topic Lead, who led the committee through the main themes of the stakeholder comments received at consultation. The committee considered the comments, made edits to the recommendation and suggested responses to the comments.

5. Fetal monitoring guideline – Documentation during intermittent auscultation

Maija Kallioinen, Topic Lead, led a discussion about the recommendation about documentation during intermittent auscultation based on an external query. Committee made no changes to recommendations.

6. Fetal monitoring guideline - CTG decelerations

The Chair introduced Ayisha Ashmore, Clinical Fellow, who gave a presentation on CTG decelerations. The committee discussed the definition of late decelerations in the fetal monitoring guideline, and agreed amendments the recommendation for clarity.

7. Neonatal infection: antibiotics for prevention and treatment guideline

The Chair introduced Sharangini Rajesh, Senior Technical Analyst, and Sarah Dwyer, Technical Analyst, who presented the context to a small update to the neonatal infection guideline around the risk of early onset neonatal infection in the context of prelabour rupture of membranes at term. The committee discussed and made amendments to the review protocol.
