## 1. Welcome and objectives for the meeting

The Chair welcomed the Committee members and attendees to the 12th meeting on Workplace Older Employees. The Committee members and attendees introduced themselves.

The Chair noted that the PHAC are not able to develop recommendations and considerations at this meeting as the meeting is not quorate; however areas that have potential for recommendations that the attendees would like to bring to the attention of the remainder of the PHAC can be identified.
