1. Welcome and objectives for the meeting

recommendations. They agreed to revisit these later in the process.

5. Evidence review RQ3 - Local approaches to suicide clusters for suicide prevention

Yingying Wang recapped discussions held during the last meeting, and presented comments made by the committee made via email.

The committee discussed the draft recommendation in the light of these comments, and made amendments to the previous version.

6. Health Economic update and discussion

Vicki Pollit and Kate Ennis presented an update from YHEC on the progress made in developing an economic model.

The committee discussed the presentation and responded to YHEC queries. The committee agreed to the formation of a subgroup and volunteers were sought.

7. Look forward to the next meeting

Hugh McGuire informed the committee of the plans for the next meeting, and asked the committee how best to focus their search for evidence.
