Benign prostatic hyperplasia only affects men.

Age: The incidence of benign prostatic hyperplasia (BPH) increases with age. It is unusual before the age of 45 and affects men of Afro-Caribbean origin at a slightly earlier age.

Disability: Some patients with BPH are likely to be covered by the Equality Act 2010 if their condition has had a substantial adverse impact on normal day to day activities for over 12 months or is likely to do so.

This was not thought to have an impact on the assessment of the procedure. No exclusions were applied.
