The impact on equality has been assessed during guidance development according to the principles of the NICE Equality scheme.

Briefing

Disability: All people with multiple sclerosis (MS) are covered by the disability provision of the Equality Act 2010 from the point of diagnosis.

Age: MS is most commonly diagnosed in people in their 20s and 30s, although it can develop at any age.

Gender: MS is more common in women than men.

Ethnicity: In an east London study published in 2016, people of African or Caribbean family origin and those of Indian, Bangladeshi, Pakistani or Sri Lankan family origin had a lower rate of MS compared to people of British, American or European family origin.

This was not thought to have an impact on the assessment of the procedure. No exclusions were applied.
