#### IPG464 Endoscopic ablation for a pilonidal sinus

#### **Briefing**

The incidence of pilonidal sinus is approximately 0.7%, around 26 per 100,000/year. It is 4 times more common in men than in women. Women who develop a pilonidal sinus tend to be younger. Pilonidal sinuses occur usually from the age of puberty to about 40 years of age, but rarely in older people and children. Hirsutism, excess weight, a deep buttock cleft and a family history may increase the risk of developing the condition. Persistent irritation, inflammation and poor hygiene will aggravate the condition.

About half of patients present as emergencies with a pilonidal abscess. People with pilonidal sinus are limited by pain and the management of their condition. If the condition is severe and has a significant and long-standing effect on their ability to carry out activities of daily living, they may be considered to have a disability.
