Age: the prevalence of COPD increases with age.

Gender: COPD is more common in men than women.

Disability: Most people with long standing COPD may meet the criteria for disability under the Equality Act 2010 if the condition has a substantial adverse impact on day-to-day activities and has lasted longer than 12 months or is likely to do so.

Socioeconomic status: COPD is closely associated with levels of deprivation - rates of COPD are higher in more deprived communities. Air pollution and polluted work conditions may cause some cases of COPD, or make the disease worse. The combining effect of occupational exposure to air pollutants and smoking increases the chances of developing COPD.

This was not thought to have an impact on the assessment of the procedure. No exclusions were applied.
