IPG657 Ultrasound-guided high-intensity transcutaneous focused ultrasound for symptomatic uterine fibroids

The impact on equality has been assessed during guidance development according to the principles of the NICE Equality scheme.

Briefing

1. Have any potential equality issues been identified during the briefing process (development of the brief or discussion at the committee meeting), and, if so, what are they?

Age: fibroids are common in people between 25 to 45 years of age and most common toward the end of the reproductive years, although they can occur in patients of any age.

Gender: this condition only occurs in people with a uterus.

Ethnicity: uterine fibroids are more common in people of Afro-Caribbean origin. Asian people have a lower incidence of symptomatic uterine fibroids.

Socioeconomic status: fibroids are more common in people with a higher body mass index (higher prevalence of obesity in people from more deprived socioeconomic groups).

Disability: people with uterine fibroids may be covered under disability in the Equality Act 2010 if their symptoms have a substantial adverse effect on day to day activities for longer than 12 months.

2. What is the preliminary view as to what extent these potential equality issues need addressing by the committee? (If there are exclusions listed in the brief (for example, populations, treatments or settings), are these justified?)

This was not thought to have an impact on the assessment of the procedure. No exclusions were applied.
