No equality issues have been identified, but the committee addressed the following considerations. The scope considered that some women of Asian family origin may be more at risk of obstetric anal sphincter injuries (OASI). Those with severe faecal incontinence may meet the criteria for disability under the Equality Act 2010. Sex, pregnancy, race and disability are protected characteristics under the Equality Act 2010.

3. Have any other potential equality issues been identified by the committee and, if so, how has the committee addressed these?

The committee stated that Episcissors-60 are intended for use in pregnant women during delivery. Women of older age are more likely to sustain anal sphincter damage. Age and gender are protected characteristics in the Equality Act 2010. The committee also stated that women who have undergone female genital mutilation may be at increased risk of OASI, although there is no evidence for this.

The committee acknowledged that women of Asian family origin may be at higher risk of OASIs due to a shorter perineal body length.
