No equality issues were identified during the scoping process. Equality considerations identified during scoping are that SEM Scanner assesses moisture levels and avoids subjective tests of skin colouration so may allow for earlier detection of tissue damage in people with dark skin tones. People with restricted mobility are at an increased risk of developing pressure ulcers and would likely benefit from this device. The committee addressed these considerations by recommending research be done to assess the clinical efficacy of using SEM scanner to prevent pressure ulcers specifically in people with dark skin tones and people with comorbidities.
