1. Welcome and objectives for the meeting

2. Confirmation of matter under discussion, and declarations of interest

The Chair outlined the objectives of the meeting.

The Chair and a senior member of the Developer's team noted that the interests declared by Mary Phillips during recruitment, prevented her from fully participating in the meeting. All other declarants were able to participate fully on the day's agenda.

- 3. The minutes from GC4 were signed off with no amendments.
- 4. CS informed the committee that the scope will be amended to include a nutrition question related to acute pancreatitis within the guideline.
- 5. The committee discussed and agreed the protocols for management of pain, pain: duct obstruction, pain: pseudocysts, pain: small duct disease and lifestyle.
- 6. Toluwa Akindele-Ajani informed the committee that no evidence was found for the aetiology of chronic pancreatitis and aetiology of acute pancreatitis evidence

reviews. The committee discussed and drafted a recommendation.

- 7. Toluwa Akindele-Ajani delivered a presentation on the biliary obstruction evidence review. The committee discussed the evidence.
- 8. Margherita Fanos presented the diagnosis of chronic pancreatitis 'linking evidence to recommendations' and the committee made minor amendments.
- 9. Emma Brockis updated the committee on the health economic plan.
- 10. The committee discussed and agreed the protocols for ascites, timing intervention and referral.
