The day's agenda also included review of protocols on Metabolic investigations, non-surgical management of asymptomatic renal stones and imaging for follow-up.

- C. Margaret Constanti (NGC) delivered a presentation to the committee on the guideline's economic priorities.
- D. Silvia Rabar (NGC) led the committee's discussions and sought their agreement on the following review protocols:
 - Metabolic investigations
 - Non-surgical management of asymptomatic renal stones
 - Imaging for follow-up
- E. Sophie Carlisle (NGC) led the committee in discussions on the Linking evidence to recommendations statement on Medical Expulsive Therapy. The committee provided feedback on the summary of discussions.
