REPORT OF DISCUSSIONS AT THE MEETING

1 Welcome and apologies

SHa welcomed everyone to the 15th meeting of the Suspected Cancer GDG.

Apologies for absence were received from Joan Meakins, Karen Sennett, Euan Paterson and Stuart Williams.

2 Declarations of interest

The following declarations of interest were noted:

- .1 DM declared that he has been asked to join a Medicines Optimisation Reference Group established by NHS England. This was categorised as personal pecuniary non-specific meaning that DM can participate in discussion on all guideline topics as medicines are not the focus of the guideline.
- .2 DM declared that he has been asked to give a presentation at the INVOLVE conference in Birmingham in November on patient perspectives of engagement in research projects and the opportunities for the patient voice to be heard and listened to. This was categorised as personal pecuniary non-specific meaning that DM can participate in discussion on all guideline topics as this is not the focus of the guideline.
- .3 RJO declared that Portable Medical Technology Ltd have recently developed a patient self-management app to assist RJO in dealing with acute complications of cancer and chemotherapy. This was categorised as non-personal-pecuniary meaning that RJO can participate in discussion on al guideline topics as this is not the focus of the guideline.

The GDG reviewed the symptom based guideline.
